


#### I Introduction

#### I.1 Generality

#### I.2 Services provided by SRDI

- Member of consortium or sub-contractor of one member.


## III.1 Hold baggage screening solutions




# III.1.1 SRDI solution design

SRDI SA proposes other security solution related to :


- Security perimeters (fences around critical area);



SRDI can provide the appropriate training for maintenance of the different equipment comprised in the proposed solutions, including screening equipments, baggage handling equipment and automation of the system.


# VI Schengen – Non Schengen solutions (For EU)
